ACTIVITY PARTICIPATION ASSUMPTION OF RISK, RELEASE,

WAIVER, AND DISCHARGE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an asymptomatic individual can be infected with and transmit COVID-19 without their knowledge.

Diamond Sports Training has put in place preventative measures recommended by the State of Pennsylvania to reduce the spread of COVID-19, however, Diamond Sports Training cannot guarantee that you, your child(ren), your spouse, or anyone else will not become exposed to or infected with COVID-19 as a result of participating in a Diamond Sports Training program, event, or activity.
